



ACCESS TO 'CASA AZZURRI – GERMANY' MEDIA CENTRE AND MEDIA OPPORTUNITIES FROM 11 JUNE 2024

1. The 'Casa Azzurri - Germany' Media Centre will be operational from **11 June 2024** and for the entire duration of Italy's involvement in the tournament.
2. Access for the media, which is supervised by FIGC staff in accordance with UEFA and FIGC guidelines, **is restricted to media representatives with UEFA EURO 2024 accreditation.**
 - 2.1 **Until 12 June**, media representatives who do not yet have a UEFA EURO 2024 badge must show a UEFA-issued certificate confirming media accreditation for the tournament, together with some ID and a journalist membership card (national or AIPS). This will no longer be possible **from 13 June**.
3. The UEFA EURO 2024 media accreditation badge only grants access to the Media Centre, which mean the media working area and the press conference room, in accordance with seating availability.
4. UEFA EURO 2024 accreditation badges must be worn at all times inside the 'Casa Azzurri - Germany' area.
5. Media representatives are admitted and allowed to remain in the media working area only if they are actually using a workstation.
6. The 'Casa Azzurri - Germania' Media Centre will be open at the following times:
 - From MD+1 to MD-1: from 10:00 until 23:00
 - MD: from 19:00 until 23:30
7. All media activities will be held in the **press conference room**, which has approximately **50 seats**. Entrance is regulated by FIGC staff at the Media Centre desk based on the scheduled times. Generally, media representatives who are not able to access the press conference room will be able to follow the press conference in a hybrid way.
8. Access to press conferences at the 'Casa Azzurri - Germany' Media Centre will be granted to i) **reporters** (rights holders, non-rights holders, printed media) providing there is space in the room, based on the principle of one representative per media outlet/group, unless additional places are free; and ii) **photographers**, in accordance with available space in the shooting areas and is limited to the first two minutes of each session.
 - 8.1 Access to the press conference room for **cameramen** is limited for space reasons and organised as follows: 1) HB and RH Italia; 2) UEFA TV; 3) MVB (according to the match calendar).

- 8.2 Any filming by 1) HB e RH Italia; 2) UEFA TV; 3) MVB must take be carried out following the instructions and the framing guidelines given by FIGC on location.
- 8.3 Distribution of images to rights-holding and non-rights-holding broadcasters who cannot access the press conference room will be organised by UEFA through its dedicated platforms.
- 8.4 Accredited media representatives who are unable to access the press conference will be able to follow **sessions remotely**: i) via the monitors in the media working area; ii) in a hybrid way through the platform with ITA/ENG simultaneous interpreting.
- 8.5 The simultaneous interpreting service is run remotely on the platform and will be available to the media representatives present via the link provided in the Media Centre. You will need to use the service on your own device (smartphone/laptop/earphones).
9. Filming of all activities organised at 'Casa Azzurri - Germany' is centralised by FIGC.
- 9.1 Apart from crews allowed into the press conference room (see 8.1) in for scheduled media activities, 'stand-up' video recordings may only take place in the **multilateral station in the media working area**. Therefore, audiovisual recordings outside the designated area and in the areas outside the Media Centre are not permitted.
10. Food must not be brought inside the Media Centre or, generally, inside all pertinent areas (press room, press conference room, TV studios, offices).
