TOPIC

The sessions will be led by **prominent legal experts, sports professionals, and institutional representatives**, with the aim of providing participants with a comprehensive and in-depth understanding of the current challenges and opportunities in football agency practice.

A distinctive feature of this course is the focus on emerging international case law and the comparative discussion of different regulatory scenarios, offering participants the opportunity to reflect on **how such developments may affect their professional activity both in Italy and abroad**.
